## MERCEDES BED AND BREAKFAST TERMS AND CONDITIONS

Settlement of Bills (Payment in Advance): Bills must be paid upon presentation. Cheques are not accepted except manager's cheques. With regard to room accommodation, our Policy is as follows:

- a. full payment prior to moving into room
- b. that guest(s) make payment in advance by midday in the event of extension of stay.
- c. Mercedes Bed and Breakfast requires a (refundable) deposit fee of Php1000.00 on arrival for any damage or losses to the property and other incidental charges.

Default: In case of default in payment of dues, the management shall have a lien over the luggage and belongings of the defaulter and shall detain the same and proceed to sell or auction such property at any time without reference to the defaulter and appropriate the net sale proceeds towards amount owed by the defaulter.

Departure: "Check out" time is 12:00 p.m. If you wish to stay up to 6:00 p.m. and the room is available, an additional 50% of standard room charge will apply. Full rate applies after 6:00 p.m. Upon departure, rooms and included fixtures are required to be in good working condition.

Right of Management: Management reserves the right of admission of any person to the premises of Mercedes Bed and Breakfast and to terminate contract of accommodation prematurely when deemed necessary as in the case of violation of the terms and conditions, disturbing the peace, violent conduct, etc.

Access to Room: Management and employees are permitted to enter any room in the ordinary course of duty to view the condition of the premises and to execute all necessary repairs and work.

Privity of Contract: For in-house/staying guest(s) the accommodation contract is between the guest(s) and/or their agents on one hand and Mercedes Bed and Breakfast on the other hand. This contract gives certain rights and obligations to both parties. These rights and obligations are not transferable to any other party who is not privy to the contract.

Room Keys: keys must be deposited at the Reception desk when leaving the hotel premises. On checkout, please surrender your key(s) at the Reception. Lost keys will be charged Php1,000.00.

Liability: The management of Mercedes Bed and Breakfast, employees or representatives are not liable and responsible for any injuries nor losses to guests, and/or their visitors regardless of the circumstances surrounding the loss of injury, accident to any person or loss of or damage to property brought upon the company's premises. Guests are advised to look after their valuables.

Vehicles. No responsibility will be taken for any loss to property or damage to vehicles or injury to persons due to fire, theft or any other cause whatsoever while on Mercedes Bed & Breakfast premises.

General Liability: In lieu of any condition or liability complied by Law, the liability Mercedes Bed and Breakfast in respect of any defect or failure in service supplied or damage attributable thereto is limited to making good replacement or refund (at the management's discretion) of only the service provided by the guest house. Any complaints must be made within 24 hours of service rendered.

Conservation: Guests are advised to conserve both electricity and water.

Damage to Property: Guests will be held responsible for any loss or damage to property of the guest house caused by themselves, their friends or any of their visitors.

Cooking: No cooking is allowed in guestrooms.

Pets: Management does not allow any pets in the premises.

Government Rules and Regulations: Any form of illegal activity is not tolerated within the hotel premises. Gambling, illicit drugs, prostitution and the like will be reported to the proper authorities. Likewise, fire arms, fireworks, flammable liquids and the like are strictly prohibited within the hotel premises.

Amendment of Rules: The management reserves to itself the right to add to, alter or amend any of the above terms conditions and rules.

We undertake to procure that I and every person accompanying me/us will accept the aforesaid conditions of residence/presence and will agree to be bound by them.
